1. Period of Contract: The contract shall be valid for a period of 01-01-2016 to 31-12-2016 (1 year). However, IIRS reserve the right to extend the same for further periods on mutual agreement or short close the same by giving one month prior notice in writing without any financial obligations on either side.

- 3. <u>Scope</u>: Annual Maintenance Contract (AMC) of AMC of Field Instruments installed at Sitra Rao Watershed at Langha Village in Dehradun for a period 01 year.
- 4. <u>Charges</u>: Please quote your lowest charges **per visit** for the AMC for 01 year. Percentage of taxes, if any, payable shall be shown separately. The rates shall remain firm and fixed till the completion of the contract period.
- **Payment**: Payment shall be made on pro-rata quarterly basis after satisfactory completion of servicing/maintenance of each visit. No other mode of payment shall be entertained.
- Spares: The Spares Parts, if any, required for the maintenance shall be provided by the Department. However, if the spares are not readily available with the Dept, but are available with the Contractor, the same shall be supplied with prior approval from the concerned Engr-in-charge duly certified by the Division Head for which payment will be made extra against production of documentary evidence. All spare parts removed from the systems being IIRS property, the same shall be left with the Division concerned. An approved list of essential spare parts with the cost shall be submitted alongwith the offer.

- 7. Security Deposit: In case of an order, you have to submit an interest free Security Deposit equivalent to 10% of the total estimated contract value in the form of Demand Draft or Bank Guarantee which will be refunded after due performance of this Contract or shall be adjusted/ forfeited against any dues.
- 8. Parallel-Adhoc Contract : IIRS reserves the right to enter into parallel/Adhoc contracts simultaneously with one or more agencies.
- 9. Fall Clause: The maintenance charges shall in no event exceed the lowest charges at which you service machines of identical description to any other party during the currency of this contract. If at any time, during the said period, you reduce the service charges of such system to any other customer, it shall be forthwith notified to us and the charges payable under the contract for servicing done after the date of coming into force of such reduction of service charges, shall stand correspondingly reduced.
- Arbitration: All disputes, differences, claims and damages arising under or pursuant to this agreement shall be refered to Arbitration of a Sole Arbitrator to be appointed by Director, IIRS. Arbitration shall be held in Dehradun and shall be subject to and governed by the provisions of the Arbitration and Conciliation Act 1996 or any statutory modifications or re- enactment there of.
- 11. <u>Termination</u>: IIRS reserves the right to terminate the contract, if the performance of the contractor or his employees is found to be unsatisfactory during its currency by giving one month notice in writing.
- 12. <u>Down-Time Compensation</u>: In case of break down calls are not attended within 48 hours from the date of intimation, down time compensation at the rate of 0.5% of the annual maintenance charges per day shall be recovered from you.
- 13. <u>Sublet of Contract</u>: You shall not sublet, transfer or assign the contract or any part thereof without our prior written approval.

## 14. General:

- 14.1 In the event of damages to our/your property or personal injury to our/your personnel due to the negligence of your employees, the responsibility shall solely rest with you. IIRS shall not be responsible for any injury/loss of life of the contractor's personnel due to natural calamities/ accidents etc.
- 14.2 In case after award of contract, you fail to execute the same, we shall get the works done through other agencies at your risk and cost.
- 14.3 Only qualified and experienced Service Engineers/Technicians shall be deputed to attend the maintenance work.
- 14.4 The contractor shall make his own arrangement for transport, canteen, safety, medical and other amenities for his personnel deputed to IIRS.
- 14.5 The work shall be done at our site during normal working hours between 09.00 hrs and 17.00 hrs. (Monday to Friday). However, IIRS reserves the right to deploy contractor's personnel on Holidays and beyond Office hours as per the requirements from time to time.
