- The oil level should be checked and made up with the speed grade of oil recommended.
- > Check the tightness of the holding down bolts, check the outer bearing housing for any misalignment.
- Check oil of all joints pins occasionally, no oil gets on the drum. Break shoes should be checked periodically for wear & lining and replace as and when necessary.
- > Lift motor should checked and regular inspection should be carried out periodically.
- > Lift ropes lubrication should be done periodically.
- ➤ Checking of all the guides, brackets, bolts & palm, lubrication of guide rails should be done properly for proper maintenance of elevators.
- > Oiling of the moving parts including PIVOT point of the gripping jaws.
- Checking of the free movement of the tension weight in the pit and checking the function of the over speed governor trip switch.
- Periodical inspection of safety gears jaws should be carried out.
- Lubrication of all moving parts and test operating to be done manually by power switch off and lifts shaft to be neatly maintain cleaned.
- The controller unit should be checked every month & cleaning of contractor point, fuses be check, auxiliary relays and electronic competent should be checked.
- > Wornout / brocken spares to be changed as and when require.
