Invitation for Expression of Interest (EOI) for providing slope protection measures at North-Eastern Side of IIRS campus, Dehradun.

Introduction :

Indian Institute of Remote Sensing (IIRS) is premier training institute of Indian Space Research Organisation (ISRO). Its campus in Dehradun is located on elevated plain surrounded by natural nullahs. Slopes on NE side of 250 Mts. Length are very critical and associated with landslides and soil erosion. Department approved to provide suitable slope stabilization measure on this stretch including land reclamation as feasible.

Brief Scope of the Project :

Consultancy services from professional agencies having experience in such slope stabilization measures. Nature of consultancy services required are:-

- Detailed survey of slopes and preparation of maps/drawings.
- Offering suitable techniques for preventing landslides and soil erosion.
- Land reclamation alongside the main road of the campus.
- Designing the technique(s) as approved by IIRS.
- Preparation of DPR including drawings, detailed measurements, cost estimation based on DSR of CPWD suitable for public tendering.
- Limited supervision during execution of works.

Eligibility Criteria:

Following are the minimum qualifying requirements for the consultant, who intend to express their interest.

- The consultant shall be an established agency having adequate experience in handling slope protection projects in Northern India during the past five years. (Evidence supported by copies of orders and project completion certificates). Consultant shall have experts like Geologists, Geotechnical engineers/experts, soil experts, hydrology experts, survey experts etc. on their pay roll. Details of manpower on payroll and tools/machines/ equipment should be enclosed.

- The consultant should have an annual turnover of not less than 5 Crores in any of the past three completed financial years (Supported by audited balance sheets).
- The Consultant should preferably be having experience in similar projects like Uttarakhand, Himachal, J&K or North-eastern states, if any (Copies shall be enclosed)

Selection Process:

The selection process would be of following two steps.

- Step 1 : Short listing of consultants based on documents submitted by them along with the Expression of Interest, in proof of satisfying the eligibility criteria given above.
- Step 2 : Short listed consultants will be invited to give presentations on their credentials, various techniques etc., to the Technical Committee of IIRS. Committee may visit some of the executed projects claimed by the consultants. Final short listing of consultants will be done based on these merits.

Only those consultants who satisfy step 1 will be invited for the evaluation process under step2. Only those consultants who are finally short listed after step 2 will be qualified for further participation of the tender.

Shortlisted consultants will be provided with full set of tender documents to furnish their tender proposal in two part Bid system i.e. Techno-commercial bid and Price bid

Submission of EOI :

Consultants meeting the above eligibility criteria and interested in participating shall submit their EOIs along with all copies of all relevant documents (to establish their eligibility), to the **Head CMD, Indian Institute of Remote Sensing, 4-Kalidas Road, Dehradun-248001, Uttarakhand** in a sealed envelope super scribing “**Expression of Interest for providing slope protection measures at Northern Side of IIRS Campus, Dehradun**” so as to reach Head CMD, IIRS before 1600 Hrs. on 08.06.2015. IIRS reserves the right to reject any or all EOIs without assigning any reason thereof.
