All Selected candidates (including Government-sponsored / nominated candidates), if willing to join the course, are required to pay the Course Fee (i.e. ₹20,000/-) for confirmation of admission latest by December 08, 2022 (23.59.59 hrs. i.e. 11:59.59 pm) and the send the proof of payment from your registered email-ID\* only, on email-id: crsadmissions@iirs.gov.in; with a CC: headacademics@iirs.gov.in as per the details given in Annexure-1, failing which their candidature shall stand cancelled and their seat will be offered to the wait-listed candidates.
- 3. Selected candidates unwilling to join the course must immediately send their unwillingness, so that the seat can be offered to the next waitlisted candidate.
- 4. All Waitlisted candidates MUST send their willingness to join the course latest by December 08, 2023 (23.59.59 hrs. i.e. 11:59.59 pm) from your registered email-ID\* only, on email-id: <a href="mailto:crsadmissions@iirs.gov.in">crsadmissions@iirs.gov.in</a>, with a CC: headacademics@iirs.gov.in failing which their candidature shall stand cancelled and their seat will be offered to the next wait-listed candidates.

Wait Listed candidates are likely to be selected in the course as and when the waitlist is operated. Only those wait-listed candidates, who have given willingness within the given deadline, shall be considered for offering vacant seat. They shall be given THREE WORKING DAYS from the date of offer, for paying the Course Fee (i.e. ₹20,000/-), failing which their candidature shall stand cancelled and the seat will be offered to next waitlisted candidates. Please refer to Annexure 1 of this Instruction sheet for fee related details. Please note that Waitlisted candidates should not pay fees unless asked.

- 5. The admission of Government-sponsored candidates, who have not submitted Nomination Certificate, will be provisional. Such candidates are required to submit the scanned copy of the Nomination Certificate from the Competent Authority of their parent organization / institute in the prescribed format latest by December 08, 2022 (23.59.59 hrs i.e. 11:59.59 pm), by email on above course ID from your registered email-ID\* only. The original copy has to be submitted on the date of registration (i.e., during admission). - 6.
