## **Result for Admissions in P.G. Diploma RS & GIS Course (2026)**

### **Important Instructions to the Candidates**

1. Results for Admissions in P.G. Diploma Course (2026) is provided here in Annexure 1.

**All selected candidates (including Government-sponsored candidates) MUST confirm the seat through the IIRS admission portal (URL: <https://admissions.iirs.gov.in/> ) to join the course and pay the course fee, within seven (07) days from the date of publication of results on IIRS Website/ Admission Portal (Last date for payment of the course fee shall be visible at the admission portal adjacent to “pay now” button). If the fee is not paid by the given last date, the selection will be cancelled and the seat will be offered to the other candidate as per norms of IIRS.**

After verification of the fee receipt at IIRS, the admission letter will be available for download in the admission portal itself, within two/one week from payment of the course fee by the selected/ waitlisted candidates, respectively (*i.e.* for selected candidates within 02 weeks and for waitlisted candidates within 01 week, from payment of the course fee by the candidate).

2. The course fee for P.G. Diploma is ₹ 72,000/- (Rupees Seventy-Two Thousand only) for the Self-Financed candidates

**No request for extension in the last date/time in confirmation of seat and payment of fee shall be entertained under any circumstances.**

3. **All Wait-listed candidates** are advised to check their status at IIRS admission portal (URL: <https://admissions.iirs.gov.in/> ) regularly. They are likely to be selected in the respective Course as and when the waitlist is operated. Once selected, the wait-listed candidate **MUST confirm the seat through the IIRS admission portal (URL: <https://admissions.iirs.gov.in/> ) to join the course and pay the course fee, within 03 days from the date of selection at admission Portal (Last date for payment of course fee shall be visible at the portal adjacent to “pay now” button). If the fee is not paid by the given last date, the selection will be cancelled and the seat will be offered to the other candidate as per norms of IIRS.**

All the selected candidates should submit the Mark sheets/ Certificates of final semester/year on the date of registration/ reporting (*i.e.*, during admission; date will be announced/informed later by IIRS). In case these documents are not available by that time (applicable only for selected

candidates whose final semester/ year result of qualifying degree is awaited), the candidate must submit a Certificate in original from the Competent Authority of his/her Institute at the time of registration stating that: (i) he/she has appeared for examination in all the subjects required for obtaining his/her qualifying degree; and (ii) he/she has obtained requisite marks [i.e. 55% or equivalent upto pre-final semester/year]. However, admission of such candidates will be provisional and they shall have to submit the Mark sheets/ Certificates of final semester/year (proving the possession of minimum qualification as per the requirement of the course) on or before the last date to be announced by IIRS. Non-fulfilment of this condition shall automatically result in cancellation of the provisional admission.

4. In case any candidate withdraws from the course before or after joining, refund of fee will be made in due course of time according to the Fee Refund Policy of IIRS, available in the website ([https://www.iirs.gov.in/iirs/sites/default/files/pdf/2024/Fee\\_Refund\\_Policy\\_IIRS.pdf](https://www.iirs.gov.in/iirs/sites/default/files/pdf/2024/Fee_Refund_Policy_IIRS.pdf) )
5. General announcements shall be made on IIRS website (<https://www.iirs.gov.in/>). Candidates must regularly check their registered emails and IIRS website for updates and necessary action at their end. IIRS does not hold any responsibility, resulting from any lacuna on part of the candidate.
